CALL TO ORDER

The meeting was called to order by the Chairman, Steve Wright, at 9:09 pm

Director's Report

Zach reported Hangars P-15 and P-20 are nearing completion. Both owners are hoping to have their Certificate of Occupancy before the end of September.

Director's Report

Zach reported the purchase of Hangar N-12 was completed on Friday, September 8, 2023. The current tenant will continue to occupy the hangar throughout the rest of their lease (with the previous owner), which expires on April 3, 2024. Ben asked if the plan is to use it as a community hangar once the lease is up. Zach answered that it is the plan for right now.

Director's Report

Zach reported that the initial work toward the next bank of T-hangars has started with a survey of the area by GMC. Representatives from GMC understand that space is currently at a premium at the Cleveland Regional Jetport, and as such have been directed to come up with additional options in which the space surrounding this T-hangar could be most efficiently utilized. Two alternative options have been presented for review to start the discussion.

Director's Report

Zach reported that after much troubleshooting of the Fire Alarm system, it has been determined that the new main panel would be needed should the current system be retained. Optionally, a different system with all new sensors and devices could be installed.

Quotes were requested from the three (3) authorized Notifier dealers in our region to replace the NFS-320 panel with an identical unit, and are as follows:

- A) Gallaher \$4,413.21
- B) 6aseSix \$4,595.00
- C) Pye*Barker No Quote Given

Quotes we requested to replace the Notifier system with a different unit and came back as follows:

- A) Wheeler Technologies (Honeywell Firelite ES200X) \$9,648.00
 - B) Pye*Barker (Silent Knight System) \$12,545.00
- C) Convergent Technologies still waiting for their quote.

Adam DeKinder reported that fuel sales are up 5% from last year. Titan says regional sales are down as a whole. The flight school logged 54 hours for July. They currently have 1 aircraft and 1 instructor.
